You will assess the client's individual status and needs, develop a treatment plan and in collaboration with all ACT Team clinicians provide or participate in the provision of core program services including comprehensive assessment, substance abuse treatment, structuring time and employment, activities of daily living, social and interpersonal relationships and leisure time, and support.

- Knowledge of a Safety Culture in a Health Care Setting in compliance with the OHSA
- Demonstrated knowledge of major mental illness from a biopsychosocial perspective
- Knowledge, skills, and recent experience providing assessment, treatment and rehabilitation of individuals with serious mental illness
- Demonstrated knowledge of and experience in applying the principles of psychosocial rehabilitation and the practices of case management
- Knowledge of psychotropic medications, symptom management, and community resources
- Knowledge of the Mental Health Act and other relevant legislation
- Excellent communication skills; both written and verbal
- Excellent organizational, time management, critical thinking and problem solving skills
- Must be capable of establishing positive interpersonal relationships and able to work as an effective team member
- Demonstrated experience using a patient-centered approach
- Self directed, self motivated to accomplish specified outcomes
- Demonstrated commitment to evidence-based practice
- Knowledge of and ability to mobilize community resources
- Experience in the development of teaching materials and the teaching of clients, family, and caregivers
- Working knowledge and experience with theories and principles of guiding adult learning and patient self-management approaches
