Reporting to the Coordinator - Infection Safety, the Infection Control Practitioner develops, implements, monitors and evaluates infection control practices within our organization, based on best practice standards proven to reduce the acquisition/transmission of pathogens amongst patients and staff. Key practices include surveillance, measures to contain organisms of epidemiological importance and outbreak management. By providing consultation, guidance and coaching regarding infection safety practices to patient care teams, the Infection Control Practitioner is influential in advancing key patient and staff infection safety initiatives. This role functions as a consultant, role model, investigator and educator responsible for recommending and implementing strategies that impact our patients and their families, all health care workers (i.e. staff, physicians and volunteers) and the public.
