In order to make this vision a reality the program ensures that all of its clinical staff have the necessary skills by providing education and training, and has in place an evaluation framework to measure quality of services delivered including client outcomes.

- Knowledge of psychiatric diagnoses and treatments, psychotropic medications and symptom management
- Strong discharge planning skills
