- to manage new equipment set up, training and photographs

- to act as a liaison with the Infection Control Practitioner to ensure CSA/Accreditation and PIDAC standards corporately are followed
- to act as a primary point of contact/liasion with other internal departments to ensure scheduling matches workload (equipment) to maximize efficiency, in collaboration with the Manager
