In order to make this vision a reality the program will ensure that all of its clinical staff have the necessary skills by providing education and training, and will put in place an evaluation framework to measure quality of services delivered including client outcomes.

Using the principles of client centered care within the context of an interdisciplinary team approach, the successful candidate will provide care to clients with severe and persistent mental illness.
